Grading Application Submission Requirements

Six (6) copies of the following information shall be submitted with this application.

- A contoured development map showing existing contours of the site and adjoining strips of non-site property and proposed contours after completion of the proposed grading and development, based on United States Geological Survey datum, with established elevations at buildings, walks, drives, street and roads, and information on necessary clearing and grubbing, removal of existing structures, excavating, filling, spreading and compacting; the City may further require the development map to be prepared and sealed by a licensed professional engineer or land surveyor.
- An accurate plat showing the location of the grading site, a description of the type and features of the soil, and details of all structures, walls, cribbing and surface protection.
- Estimated grading quantity
- Details of site drainage system
- Details of site erosion and siltation control, including siltation basins
- Construction access to site
- Location of temporary off-street parking (shall not be within the City right-of-way)
- Sources of off-site fill material or spoil sites, and all information relative to haul routes, trucks and equipment.
- The applicant shall supply the information as defined within Section 410.110, para. G., and as defined and required by the City at the time of submittal of application with respect to use of City streets.
- The estimated schedule of operations, including the dates of starting and completion of grading work.
- Escrow and/or Surety or Bond – Amount to ensure completion of said project and restoration of City right-of-way. (In an amount to be determined by the City to be sufficient)
 - Escrow
 - Surety (surety of bond or indemnity agreement for not less than \$1,000.00)

Grading Permit Requirements

The individual or corporation to whom this permit is issued shall ensure and be responsible for ensuring all requirements defined herein are complied with in full.

- The Standards – Safety Precautions as define in Section 410.110, para. E.
- Use of City streets – the applicant as part of acceptance of this permit shall comply with requirements and agreements as define within Section 410.110.
- Construction Dirt, Debris and Noise – Section 410.110, para. J.

Mandatory Inspection Requirements:

- Applicant must be made with St. Louis County after receiving approval from the City of Green Park.
- Request for inspections shall be made in made in accordance with St. Louis County requirements.
- No construction material or debris shall be stored or left on the roadway overnight unless the City gives approval to do so.
- Correction of Deficiencies – Section 410.110, para. K.
