REGULAR MEETING:

1. Discussion on Annexation Documents and Presentation

City Administrator James Mello presented a draft Frequently Asked Question (FAQ) Sheet, stating that it was going to be one part of a mailer to residents in both Green Park and the proposed annexation area. The sheet outlined some of the basic information and benefits and incorporation. Mr. Mello explained that, from conversations he recently had with residents from the proposed annexed area, there were several misconceptions and false information being disseminated – the FAQ Sheet aims to remediate some of those issues.

A general discussion ensued regarding minor changes and edits to the FAQ sheet. Once finalized, it was suggested to post the FAQ sheet on the City’s nextdoor.com account as well.

It was suggested that for future discussions, crime reports for the annexed area be examined and a budget overview of anticipated cost increases be reviewed.

Mr. Mello continued the discussion by outlining his planned presentation to the Boundary Commission, at a public hearing scheduled for November 13th. A general discussion ensued about language choice and other minor changes.
